Good evening,

Tonight the Stewardship Committee reviewed the application for a modification to a major site plan approval from Ferris Development dated March 6, 2024. This concerns the proposed 40B development at 118-120 Turnpike Road.

The Stewards find nothing in the proposed modification and alternatives to be acceptable. Therefore we request that the Planning board **not waive** the legally binding site plan requirement regarding the 6.2 acres. We further request that the Planning Board take all appropriate steps with the appropriate parties to enforce the transfer of the 6.2 acres to the Town as conservation land (as requested previously per the email below). We also request that the Planning Board not accept the alternatives put forth in the proposed modification. Those alternatives pale in comparison to the addition of 6.2 acres that abut the existing Breakneck Hill Conservation Land, the crown jewel of Southborough's conservation land.
