7:40 p.m. to 7:42 p.m. A joint meeting was held with the remaining members of the Planning Board to fill the vacancy on the Planning Board until next Town Election on May 11, 1987. Planning Board members present were: Charles Gaffney (Chairman), David Scattergood, and Donald Morris. Mr. Gaffney placed in nomination the name of David W. Parry, 22 Main Street. No other names were placed in nomination. A roll call vote was taken: 3 members of the Board of Selectmen and 3 members of the Planning Board cast their votes for Mr. Parry.

7:45 p.m. to 7:48 p.m. Personnel Board member Arthur Miner gave an update on evaluation and Salary Administration Plan.

8:00 p.m. to 9:00 p.m. Kwan Associates Site Plan Hearing continued from 5/13/86 re 33 Turnpike Road (Assessors' Map 39, Lot 21). Jeffrey Grossman gave the presentation for Tony Kwan. Others present were: Tony Kwan (applicant), Charles Gaffney (Planning Board), David Goodemote and John Struzziery (S E A Consultants Inc.), Frank Ching (V.P., H.W. Moore Associates), Highway Superintendent John W. Boland, and several abutters. Mr. Grossman stated that no outside storage would be allowed by Plywood Ranch. State DPW has approved deceleration/acceleration approach. Highway Supt. Boland will be on the site to check landscaping and sight distance. After a lengthy discussion, Board of Selectmen unanimously VOTED to approve the Site Plan as presented subject to all of the conditions and representations made at the Site Plan Hearings of May 13 and 27, 1986, specifically, but not limited to, the ability of the Highway Superintendent to be satisfied with the site distance as it pertains to landscaping upon the proposed site.

9:05 p.m. to 9:25 p.m. A. J. Lane Site Plan Hearing continued from May 13, 1986 re 250 Turnpike Road (Map 27, Lot 2A). Present for A. J. Lane: Paul A. Chisholm, Director of Development, and William Robertson, Engineer. May 20, 1986 letter was read into the record by Mr. Chisholm. He stated that there was a typing error which he corrected and initialed: 5 inches should have been 5 feet. Others present were: members of the Planning Board and Highway Supt. Boland. After the discussion, the Board unanimously VOTED to approve the Site Plan as submitted conditional upon the provisions of a letter dated May 20, 1986 from A. J. Lane & Co., Inc. as initialed and signed by Paul A. Chisholm, Director of Development; and further conditional upon all of the representations and assurances made at the Site Plan Hearings of May 13 and 27, 1986.

Chairman Cipriano gave a report on a proposal by Mass. Turnpike Authority to put a toll booth in Southborough. They plan to eliminate the tollbooth in Natick. Other improvements are planned.

Board proclaimed June 7 to 13, 1986 as Water Conservation Week.

Re: Proposed Policy re Safety/Security. Before the Selectmen act on this policy, they would like the Town Counsel to review it. Board will vote on this at the next meeting of the Board.

Before acting on the request of Michael and Anita Backer to close to traffic Reservoir Drive on June 21 from 11 a.m. to 8 p.m. for the purpose of celebrating a Bar Mitzvah, Selectmen would like the Backers to come to a meeting (either on June 3 or 10) to discuss this matter. The Selectmen would like proof that the residents of Reservoir Drive agree or do not oppose this request.


Board granted Permit requested by New England Telephone. The work (near Pole #99) will actually be in the sidewalk, not in the street (Cordaville Road near the Mass. Turnpike bridge). Location approved by Highway Supt. Boland.
